Structured Financial Messaging System (SFMS) is a universal platform for carrying messages pertaining to major payment and non-payment system applications, thus, meeting the requirements of messaging for both retail and large value transfer of funds. An introduction on usage of SFMS messaging for Letters of Credit (LCs) and Bank Guarantees (BGs) will also be covered in the programme.
