Sealed quotations are invited for the work mentioned above and should be addressed to the Director, IDRBT, Masabtank, Hyderabad, to reach IDRBT not later than <u>17.00 hrs. on 27.11.2017</u> with an <u>EMD of</u> Rs 17,000/-.

- 1. The Institute reserves the rights to accept or reject any or all the quotations in full or in part without assigning any reasons thereof and reserves the right to accept the quotation of any firm partly or fully.
- 2. The Institute reserves the rights to increase or decrease the quantities up to any extent and no claims in this regard would be entertained. The Institute may also remove any item from the tender for which the bidder shall not have any claim thereof. There may also be an increase / modification of any items for which payment shall be made as per rate analysis.
- 3. The quotation shall be valid for a period of 90 days from the date of opening of the same.
- 4. The firm is requested to quote unit rates and amounts separately in the enclosed Performa (Bill of Quantity) only. The rates quoted must be exclusive of GST and the GST percentage shall be indicated against the value of work done at the designated place in the BOQ.
- 5. The firm shall furnish Earnest Money Deposit in the form of a Demand Draft in favour of IDRBT, Hyderabad for a sum of Rs 17,000/-. Quotation, which is not accompanied by EMD in the form of DD, will not be considered. The EMD does not carry any interest and the same will be released after rectification of defects found, if any in DLP of one year. However, the EMD will be returned to the unsuccessful bidder after placing the work order with successful bidder.
- The rates quoted shall be inclusive of levies, transport, packing, forwarding charges, and including installation charges etc. No extra charges will be paid over and above the quoted rates.
- 7. TDS will be deducted as per IT rules.
- 8. The following terms of payment will apply to the contract.
 - a) 90% of the quoted rate will be released after completion work an actual measurement basis.
 - b) Balance 10% of the quoted rate, which would include the EMD will be released after expiry of defects liability period of one year along with EMD.
- 9. The payment for the above work will be made by IDRBT, Hyderabad on actual measurement of work done by having joint measurements with the vendor. Any dispute arising out of this contract will be sorted out within the jurisdiction of Hyderabad, T.S.



- 10. The firm may consult Institute's Engineer (*Cell:* 9617773419) and should thoroughly acquaint themselves the nature and the scope of work before quoting, if required.
- 11. The entire works shall be completed and handed over to IDRBT positively within 45 days from the date of work order, failing which *Liquidated Damages (LD)* at the rate of 0.25% of the tender cost per week for the delay in completion of work beyond the stipulated period with an upper ceiling of 5% of the contract amount will be levied.
- 12. The firm shall make good the damages caused to the Institute's property during the execution of the work at no extra cost.
- 13. The firm shall be fully responsible for all type of loss, damages during the execution of the works including Mishap / accident with any person.
- 14. The firm should quote on the above terms and conditions as per the enclosed bill of quantities and no deviations shall be allowed. The quotation will not be considered if any deviation found in the above terms and conditions.
- 15. <u>The EMD will be forfeited</u>, if the firm fails to execute the work after placing the work order.
- 16. The materials proposed to be used shall be got approved by Institute's Engineer before installation. The work is to be carried out in consultation with Institute's Engineer.
- 17. If the vendor fails to rectify any damages incurred to Institute's property, clear the site even after repeated reminders or doesn't settle all dues before settlement of bills the Institute reserves the right to get such work done through other agencies & recover the cost from the amount of the bill.
